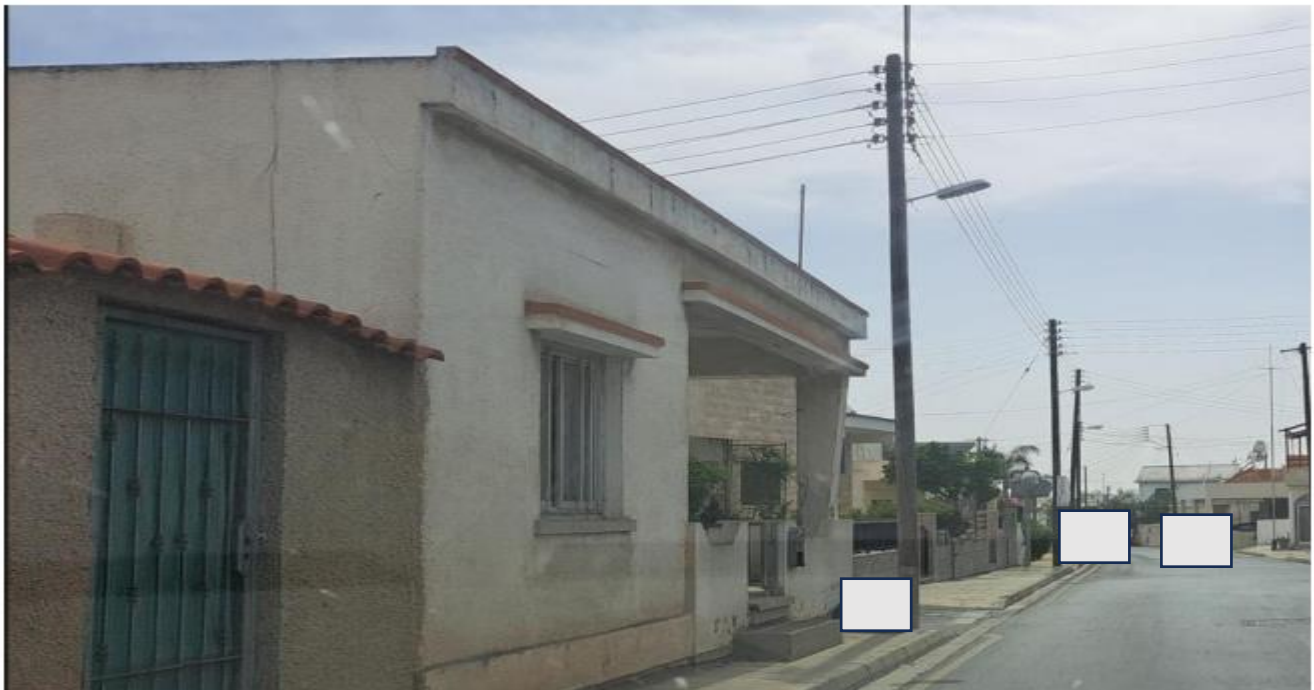

It abuts on a registered asphalt road on a face of approximately 13 meters on its northern border and approximately 10 meters on its western border. A ground-floor residence was built around 1980 on the plot, which is in a poor state of maintenance.
