Group Profile

Founded in 1899, Bank of Cyprus Group is the leading banking and financial services group in Cyprus. The Group provides a wide range of financial products and services which include retail and commercial banking, finance, factoring, investment banking, brokerage, fund management, private banking, life and general insurance. The Group operates through a total of 280 branches, of which 144 operate in Russia, 130 in Cyprus, 1 in Romania, 4 in the United Kingdom and 1 in the Channel Islands. Bank of Cyprus also has representative offices in Russia, Ukraine and China. The Bank of Cyprus Group employs 6.747 staff worldwide. At 30 June 2014, the Group's Total Assets amounted to €28,6 bn and Total Equity was €2,8 bn.

The Annual General Meeting ("AGM") of the shareholders of the Bank of Cyprus Public Company Ltd ("the Company") was held at the Company's Headquarters on **Thursday**, **20**th **November 2014.** The AGM was attended by 472 shareholders, either in person or by proxy, who represented 4.143.848.915 shares, that is 46,44% of the total issued share capital of the Company.

The AGM discussed the Directors' Report, the Auditor's Report and the Consolidated Financial Statements for the year 2013 and the Board of Directors' Remuneration Report and fixed the remuneration of the Members of the Board.

The AGM noted the re-appointment of Ernst & Young as the Company's Auditors for the year 2014, based on Section 153 (2) of the Companies Law and authorised the Board of Directors to fix their remuneration.

The AGM also considered and approved all of the special resolutions included in the Notice convening the AGM for the amendment of the Company's Articles of Association.
